1. Sealed single-part bids are invited from eligible and experienced bidders by the undersigned on behalf of North Eastern Electric Power Corporation Ltd. for the following :

Selected firm(s) will be enlisted for a period of 1(one) year for supply of computer spares.

2. QUALIFYING REQUIREMENTS

2.1 Technical

- 2.1.1 The interested Bidders shall be Authorised Dealers of Hita/Uniline/APC/Microtek/Smartpower/Libert/Elant/Quanta/Amaraja/Okaya/Panasonic and they shall submit valid Authorisation Certificates from the respective Manufacturers.
- 2.1.2 Bidders must have experience of supplying Computer Spares to any Government Department/Public Sector Undertaking. They shall furnish at least 3(three) copies of orders placed on them during last two years prior to the date of publication of the Notice Inviting Bids.

2.2 Financial

- 2.2.1 Bidders are required to possess Average Annual financial turnover during the last three years, ending 31st March of the previous financial year, for Rs 5,00,000.00 (Rupees five lakhs only).
- 2.2.2 Copies of Audited Balance Sheet/Financial Statements certified by a Chartered Accountant indicating the minimum Average Annual financial turnover and latest Banker's Certificate in support of solvency shall be furnished alongwith latest and valid Sales Tax Clearance Certificate.

3. Only those interested bidders who fulfill the qualifying requirements as mentioned at 2.1 and 2.2 above, shall download the detailed bid documents from NEEPCO website www.neepco.gov.in with effect from 18-01-2010 and submit the same alongwith their Offer to the undersigned on the appointed date and time as mentioned below. Every page of each Volume of the detailed bid documents shall be signed and stamped with proper seal by the bidders. In the event detailed bid documents are downloaded from NEEPCO's website, the cost of detailed bid documents shall be compulsorily submitted alongwith bids in the form of Demand Draft / Banker's cheque drawn in favour of NEEPCO Ltd., payable at Shillong and any such bid submitted without this Fee shall be rejected.

For those bidders who download the detailed bid documents from NEEPCO's website, documentary evidence in support of Technical and Financial Qualifications shall be submitted in a separate envelope at the time of submission of bids, alongwith cost of detailed bid documents. Bids of only those bidders, who fulfill the qualifying requirements, as mentioned at 2.1 and 2.2 above, shall be accepted. Bids submitted without fulfilling the Qualifying requirements, as indicated at 2.1 and 2.2 above, shall be rejected.

Non-transferable bid documents may also be purchased by interested eligible bidders on submission of written application to the undersigned and upon payment of non-refundable fee, as indicated above, as cost of detailed bid documents, in the form of Demand Draft / Banker's cheque drawn in favour of NEEPCO Ltd., payable at Shillong. Only those interested bidders who fulfill the qualifying requirements as mentioned at 2.1 and 2.2 above, shall request for issue of detailed bid documents.
