2. The experience certificate regarding execution of orders for similar supplies or orders for supply of similar materials to Government / PSUs during last two years will have to be submitted alongwith the bid. Non-submission of copy of certificate or supply orders may result in disqualification.

3. Earnest money to be deposited alongwith the tender: 2 ½ % (two and half percent) of the quoted value in the form of Demand Draft only pledged in favour of NEEPCO Ltd., Umrongso (SBI Branch Code No. 4812). Tenders without EMD will be summarily rejected.
4. Earnest money submitted by the successful bidder shall be retained as security deposit towards satisfactory execution of the order and will be released after delivery of entire quantity to the satisfaction of the Corporation.
5. Prices shall be on FOR Umrongso basis inclusive of all charges but exclusive of taxes and duties. The rates for taxes and duties should be separately and clearly indicated. All prices and rates should be clearly written both in figures and in words.
6. 100% payment shall be made after receipt of materials in full and good condition at site. All bank charges will be to the contractor's account.
7. All the materials should be delivered within 15 (fifteen) days from the date of order.
8. For delay in delivery, LD @ ½% per week of delay subject to a maximum of 15% of total contract value shall be applicable.
9. The successful bidder shall be bound to supply the materials to the satisfaction of the Engineer-in-charge. If any defective material is supplied, the same shall be replaced immediately by the supplier and without any extra cost to the Corporation.
10. The Corporation reserves the right to reject any or all of the bids without assigning any reason thereof and is not bound to accept the lowest bid.
11. All the above terms and conditions are non-deviable. Tenders not subscribing to all the above may be summarily rejected.
12. Sealed tenders with NIT number superscripted on the envelope should be submitted to the undersigned either by hand with written authorization or registered post. The undersigned shall not be responsible for any postal delay.
